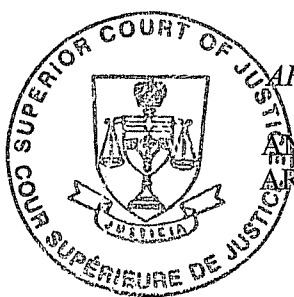

ORDER

THIS MOTION, brought by Jacques Whitford Stantec Limited ("JW Stantec"), a creditor, for an Order lifting the stay of proceedings imposed by the Order of the Honourable Mr. Justice Morawetz dated August 12, 2009 for the limited purpose of allowing JW Stantec to perfect certain construction liens, was heard this day in Toronto.


ON READING the Notice of Motion and the Affidavit of Bryan Skolnik sworn on October 30, 2009, the Affidavit of Rogelio Mercado sworn November 4, 2009, and on hearing the submissions of counsel for JW Stantec and other counsel present at the hearing of the motion,

1. THIS COURT ORDERS that the stay of proceedings imposed by the Order of Mr. Justice Morawetz dated August 12, 2009 shall be and is hereby lifted for the sole and limited purpose of permitting the perfection of construction liens which were preserved on September 25, 2009, by JW Stantec, specifically by permitting the issuance of a statement of claim against

Skypower Corp. in the form substantially the same as that attached as *Schedule "A"* to this Order, and by permitting the registration of a Certificate of Action on title to the properties described therein.

2. THIS COURT ORDERS that the stay of proceedings imposed by the Order of Mr. Justice Morawetz dated August 12, 2009 shall continue to apply in all other respects.

3. THIS COURT ORDERS that nothing in this Order shall be deemed to be an acceptance or approval by this Court or by SkyPower Corp. of the statements made in the Statement of Claim attached hereto and that notwithstanding paragraph 13 thereof, JW Stantec's liens, if ultimately determined to be valid, shall be subordinated in all respects to any and all court-ordered charges granted in these proceedings.

TO THE DEFENDANT

IF YOU WISH TO DEFEND THIS PROCEEDING, you or an Ontario lawyer acting for you must prepare a statement of defence in Form 18A prescribed by the Rules of Civil Procedure, serve it on the plaintiff's lawyers, or, where the plaintiff does not have a lawyer, serve it on the plaintiff, and file it, with proof of service, in this court office, **WITHIN TWENTY DAYS** after this statement of claim is served on you, if you are served in Ontario.

~~If you are served in another province or territory of Canada or in the United States of America, the period for serving and filing your statement of defence is forty days. If you are served outside Canada and the United States of America, the period is sixty days.~~

~~Instead of serving and filing a statement of defence, you may serve and file a notice of intent to defend in Form 18B prescribed by the Rules of Civil Procedure. This will entitle you to ten more days within which to serve and file your statement of defence.~~

IF YOU FAIL TO DEFEND THIS PROCEEDING, JUDGMENT MAY BE GIVEN AGAINST YOU IN YOUR ABSENCE AND WITHOUT FURTHER NOTICE TO YOU. IF YOU WISH TO DEFEND THIS PROCEEDING BUT ARE UNABLE TO PAY LEGAL FEES, LEGAL AID MAY BE AVAILABLE TO YOU BY CONTACTING A LOCAL LEGAL AID OFFICE.

IF YOU PAY THE PLAINTIFF'S CLAIM, and \$1,000.00 for costs, within the time for serving and filing your statement of defence, you may move to have this proceeding dismissed by the court. If you believe the amount claimed for costs is excessive, you may pay the plaintiff's claim and \$100.00 for costs and have the costs assessed by the court.

CLAIM

1. The plaintiff claims:

- a) payment from the defendant, Skypower Corp. of the sum of \$.242,296.58 plus G.S.T.;
- b) a declaration that the plaintiff is entitled to a lien under Part III of the *Construction Lien Act*, R.S.O. 1990, c. C.30 (the "*Act*"), against the interests of the defendant in the lands and premises against which the plaintiff has registered its claims for lien, as more particularly described below (hereinafter the "*Premises*");
- c) that in default of payment of the said sum of \$242,296.58, together with interest thereon and costs by the defendant, Skypower Corp., all the estate and interest of the defendant, Skypower Corp., in the premises may be sold and the proceeds applied in and towards payment of the plaintiff's claim and costs, pursuant to the provisions of the Act;
- d) a declaration as to the amount of and an accounting with respect to any and all holdbacks retained or required to be retained by the defendant, Skypower Corp. with respect to the construction improvement described below;
- e) payment of the costs of this action on a substantial indemnity basis plus applicable goods and services taxes thereon;
- f) payment of pre-judgment and post-judgment interest pursuant to the provisions of the *Courts of Justice Act*, R.S.O. 1990, c. C.42, as amended;

- g) for the purposes aforesaid and for all other purposes, that all proper directions be given, accounts taken and inquiries made; and
- h) such further and other relief as this Honourable Court deems just.

2. Jacques Whitford Stantec Limited (“JWSL”) was a wholly-owned subsidiary of Stantec Consulting Ltd. (“Stantec”), a company incorporated pursuant to the laws of Canada, which carries on business in, *inter alia*, Ontario, as a global design firm providing, *inter alia*, professional consulting services in planning, engineering, architectural and environmental sciences. On November 1, 2009, JWSL distributed its assets and liabilities to Stantec, making Stantec the successor in interest to JWSL. Following the distribution of assets and liabilities to Stantec, JWSL was thereafter dissolved.

3. The defendant, Skypower Corp. (“Skypower”) is a corporation incorporated under the *Canada Business Corporations Act*, which at all material times, maintained a leasehold interest in the Premises, upon which an improvement was made and to which the plaintiff supplied services and / or materials.

4. Pursuant to an ongoing agreement made on or about April, 2008 and June 15, 2009 (the “Agreement”) the plaintiff was hired by Skypower to provide a biophysical survey in furtherance of ministry approval pursuant to Regulation 115 of the *Environmental Assessment Act*. The plaintiff has completed its obligations under the Agreement to date and continues to do work pursuant to the Agreement with Skypower. Skypower has refused or neglected to pay the amount which is due and owing to the plaintiff, namely the sum of \$242,296.58.

5. By reason of supplying the aforesaid materials and services, the plaintiff is entitled to a lien upon the interest of Skypower for the sum of \$242,296.58 together with costs of this action pursuant to the provisions of the *Act*.

6. On August 12, 2009 Skypower, as applicant, obtained an order (the "CCAA order") under the provisions of the *Companies' Creditors Arrangement Act*, R.S.C. 1985, C. C-36, imposing, *inter alia*, a stay of all proceedings against Skypower.

7. On or about the 25th day of September, 2009 the plaintiff caused to be registered a claim for lien against the title to the Premises:

- (a) in the Land Registry Office for the Land Registry Division of the County of Prince Edward bearing Instrument No. PE 186875 as more particularly described in Schedule "A" attached hereto; and
- (b) in the Land Titles Office for the Land Titles Division of the County of Prince Edward bearing Instrument No. EC 11423 as more particularly described in Schedule "A" attached hereto

8. On November 5, 2009, the plaintiff obtained an order lifting the stay of proceedings imposed pursuant to the CCAA Order, permitting the plaintiff to perfect its liens in accordance with the *Act*.

9. The Premises are the lands and premises in which Skypower maintains a leasehold interest and are the lands and premises to which the plaintiff supplied the services and /or materials described above.

10. Skypower was at all material times the "owner" of the Premises within the meaning of the *Act*, at whose express or implied request and upon whose credit or on whose behalf or with whose privity or consent or for whose direct benefit, the plaintiff furnished the services and / or materials hereinbefore referred to.

11. In the alternative to its claim under the Agreement, the plaintiff pleads that by reason of the furnishing of its services and / or materials to the Premises it has enhanced the value of the Premises and Skypower has received the benefit of the same and has been unjustly enriched in the amount of \$242,296.58 at the expense and detriment of the plaintiff. The plaintiff pleads and relies upon the doctrine of unjust enrichment.

12. In the further alternative, the plaintiff pleads that it is entitled to payment of its claim from Skypower on the basis of *quantum meruit*.

13. The plaintiff states that its liens, as described herein, which have been preserved, have priority to the extent provided under the *Act* over all of CCAA charges granted pursuant to the CCAA Order and any related further orders related thereto.

14. The plaintiff further pleads and relies upon the priorities granted to it as a lien claimant pursuant to section 77 of the *Act*.
